ORDER APPROVING RESRAM TARIFF FILING

Issue Date: December 9, 2025

Effective Date: February 1, 2026

On September 29, 2025, Union Electric Company d/b/a Ameren Missouri filed a tariff revision and supporting testimony to modify rates under its Renewable Energy Standard Rate Adjustment Mechanism (RESRAM) to recover costs for the twelve-month period of August 2024 through July 2025. Ameren Missouri's RESRAM Rider requires it to make periodic filings to adjust for changes in its Actual Renewable Energy Standard costs for each accumulation period. The recovery period for this adjustment is February 2026 through January 2027. The tariff sheet bears an effective date of February 1, 2026, and has been assigned Tracking No. JE-2026-0045. The Commission directed notice, set an intervention deadline, and ordered the Staff of the Commission (Staff) to file a recommendation.

On November 24, 2025, Staff recommended the Commission issue an order approving the tariff sheet. The prospective RESRAM rate charged to ratepayers is \$0.00207. Ratepayers using 1,000 kWh per month will see a \$2.07 billing charge, which is a \$1.06 increase per month when compared to the previous period RESRAM rate of \$0.00313 per kWh. Application of this rate will not exceed the annual rate cap pursuant to Section 393.1655 RSMo, (Supp. 2024). No parties responded to Staff's

recommendation, and no other parties besides Staff responded to Ameren Missouri's tariff sheet filing.

The Commission has reviewed the proposed tariff sheet and Staff's recommendation and memorandum, and the Commission finds the tariff sheet conforms to Commission Rule 20 CSR 4240-20.100. The Commission concludes that the proposed RESRAM adjustment tariff sheet should be approved.

THE COMMISSION ORDERS THAT:

1. The following proposed tariff sheet filed on September 29, 2025, by Ameren Missouri, assigned Tracking No. JE-2026-0045, is approved to become effective on February 1, 2026:
