A. I support the Company's request for the amount of Pension and Other PostRetirement Welfare ("OPEB") costs to be included in the revenue requirement for

## 4 Q. WHAT AMOUNT OF PENSION EXPENSE IS EMPIRE REQUESTING IN 5 THIS CASE?

- A. At this time, Empire is requesting total annual Missouri pension expense of
  \$8,374,395, which represents an increase of \$1,126,729 to the amounts recovered in
  rates pursuant to Case No. ER-2014-0351. This total includes actuarially determined
  expense of \$7,226,856 and five-year tracker amortization of \$495,855 for the pension
  plan, as well as actuarially determined expense of \$651,684 for the Supplemental
  Executive Retirement Plan ("SERP").
- 12 Q. WHAT AMOUNT OF OPEB EXPENSE IS EMPIRE REQUESTING IN THIS13 CASE?
- A. At this time, Empire is requesting total annual Missouri OPEB expense of
  \$2,412,401, which represents an increase of \$1,529,257 to the amounts recovered in
  rates per Case No. ER-2014-0351. This total includes actuarially determined expense
  of \$2,663,976 and negative five-year tracker amortization of (\$251,575).
- 18 Q. ARE THESE THE FINAL EXPENSES FOR BOTH PENSION ("FAS 87")
  19 AND OPEB ("FAS 106") COSTS FOR 2015?
- A. No. The 2015 actuarial valuation of the plans, which provides the cost, is not yet
   complete. The amounts set forth above represent the actuary's estimates of the final
   amounts.
- Q. WILL UPDATED EXPENSE AMOUNTS BE AVAILABLE FOR A TRUE-UP
  AS OF MARCH 31, 2016, IN THIS CASE?

- 1 A. Yes. The final 2015 annual expense will be known once the actuarial valuation is
- 2 completed, and will be provided in true-up testimony.
