On December 10, 2025, the Staff of the Commission (Staff) filed its Recommendation with attached Memorandum regarding Summit Natural Gas of Missouri, Inc.'s (Summit) 2023-2024 Actual Cost Adjustment filing. Staff listed certain comments, concerns and recommendations as set forth in the Billed Revenue, Actual Gas Cost, Reliability Analysis and Gas Supply Planning, and Hedging sections.

Staff requested that the Commission order that Summit respond within 30 days to Staff's concerns, comments, and recommendations included in the Staff Recommendation and Memorandum.

The Commission will direct Summit to respond.

THE COMMISSION ORDERS THAT:

1. No later than January 12, 2026,¹ Summit shall file a response to Staff's concerns, comments, and recommendations.
