On December 10, 2025, the Staff of the Commission (Staff) filed a Status Report. Staff states that the parties are attempting to negotiate their differences, and that the parties asked Staff to file this Status Report to inform the Commission of the negotiations. Due to the parties' continued negotiations, Staff asks the Commission to find good cause to not issue the otherwise statutorily required report and order within 120 days of its' filing.¹ Staff further asks the Commission to order the parties to file a stipulation or a status report no later than February 12, 2026.

The Commission finds Staff's requests reasonable, and it will grant them.

THE COMMISSION ORDERS THAT:

1. The Commission finds good cause has been shown to waive the 120-day requirement of Section 386.800(3) RSMo.
2. The parties shall file a stipulation or a status report no later than February 12, 2026.
