On November 4, 2025, the Commission issued its Report and Order denying Jim Moriarity's complaint. That order became effective on December 4, 2025. Mr. Moriarity filed a timely application for rehearing titled a Request for Reconsideration on December 4, 2025. On December 15, 2025, Missouri-American Water Company (Missouri American) filed a Response asking the Commission to deny the Complainant's request.

The Complainant's filing asks the Commission to reconsider the issues already discussed in the original hearing. The Response filed by Missouri American opposes rehearing the issues in the hearing. The Commission will not rehear issues already discussed in a full and fair hearing.

Section 386.500.1, RSMo 2016, states that the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, the application for rehearing does not demonstrate sufficient reason to rehear the matter.

The Commission will deny the application for rehearing.
