On November 25, 2025,¹ new counsel for Respondent Stephen L. Johnson d/b/a Colony Cove, Inc. and/or Sequiota Investments, Inc. entered his appearance. On December 9, a procedural conference was held to discuss the setting of a new procedural schedule.

On December 22, the Manager of the Manufactured Homes and Modular Units Program (MHMU Manager), on behalf of itself and Respondent, filed a *Proposed Joint Procedural Schedule*. The Commission finds the *Proposed Joint Procedural Schedule* reasonable and will order it.
