SUMMARY

On December 12, 2025, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") provided its documentation regarding completion of the in-service requirements in response to Staff data requests 191 and 192. The in-service requirements were previously laid out in Confidential Schedule SEL-r2, attached to the rebuttal testimony of Missouri Public Service Commission ("Commission") Staff ("Staff") witness Shawn Lange and ordered by the Commission in its June 12, 2024, Order Granting Certificate of Convenience and Necessity in this case. Staff reviewed Ameren Missouri's documentation and concludes that the Vandalia Solar Energy Center is fully operational and used for service in accordance with Section 393.135 RSMo. as of December 12, 2025. Staff's review is attached as Confidential Schedule AA-1. Staff understands that Ameren Missouri intends to utilize the Vandalia Solar Energy Center as a part of Phase 3 of its Renewable Solutions Program ("RSP").

Additionally, Staff reviewed Ameren Missouri's proposed Phase 3 RSP tariff sheet bearing Tariff Tracking Number JE-2026-0068 and concludes that the rate schedule therein complies with the Commission's prior orders in this case and sets out rates that are just and reasonable. However, the tariff is based on inclusion of the Bowling Green Solar Energy Center which is not yet

operational. Therefore, Staff is recommending the Commission reject the tariff and order Ameren Missouri to file a substitute tariff limited to only the inclusion of the Vandalia Solar Energy Center.

CONCLUSION

Staff Recommends the following:

- The Commission find the Vandalia Solar Energy Center fully operational and useful for service.
- The Commission consider the Bowling Green Solar Energy Center **not** fully operational and useful for service.
- The Commission approve the rate schedule contained in Tariff Tracking Number JE-2026-0068, subject to the following conditions:
 - The Commission reject tariff JE-2026-0068 as currently filed, and
 - Order Ameren Missouri to file a new substitute tariff for its RSP Phase 3 which is limited to only the inclusion of the Vandalia Solar Energy Center.
