This email is a continued deficiency notice for your annual report. Your annual report is considered deficient until the following issue(s) are addressed:

- The annual report's identification of the certificate/registrations held by the company fail to match MoPSC records. Our records indicate the company is an IVoIP provider, not CLEC and IXC.
- Section 392.550.3(7)(C)RSMo requires companies providing IVoIP service to submit, as part of their annual reports, the number of customers or lines served in each exchange, and requires the Commission to maintain such information as proprietary and not available to the public. The document you previously submitted contains information regarding the number of customers or lines served in your exchange(s) in the public document. Therefore, the company must resubmit its report in two forms, a public (with line counts redacted, even if reporting zero) and non-public version. The Commission has changed the designation of the public version to non-public to keep the line counts proprietary.

Please resubmit your revised annual report in its entirety if your annual report needs to be revised to correct the deficiency. Any revised annual report/response must be filed within the Missouri Commission's Electronic Filing and Information System (EFIS) using the identification number(s) in the subject of this email.

This deficiency must be resolved within the next 20 days. Failure to respond and adequately resolve the deficiency by this deadline may result in punitive action against the company.

- Item 2 on page 2 was not completed in the confidential version.
- The verification page is lacking notarization.
