ORDER ACKNOWLEDGING SUSPENSION OF TARIFF SHEET

Issue Date: December 31, 2025

Effective Date: December 31, 2025

On December 19, 2025,¹ Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy) filed a revised tariff sheet adjusting steam heat rates. The tariff sheet has an effective date of January 1, 2026, and has been assigned Tracking No. JE-2026-0077. On December 23, Evergy filed a *Motion for Expedited Treatment* requesting the Commission issue an order approving the tariff sheet. In response, later that same date, the Commission issued an order shortening the time for parties to respond to Evergy's motion to December 30.

On December 30, Evergy, the Staff of the Commission, and the Office of the Public Counsel jointly filed a *Motion for Order Recognizing Extension of Tariff Effective Date* in which the parties state that they are in agreement that Evergy should extend the effective date of the tariff sheet from January 1, 2026, to January 18, 2026, to allow further exchange of information and discussions amongst the parties and that Evergy is extending the effective date of the tariff sheet to January 18, 2026. Therefore, the parties request the Commission issue an order that recognizes Evergy's extension of the effective date of the tariff sheet, relieving the parties of responding to Evergy's *Motion for Expedited Treatment*.

¹ Unless otherwise noted, all dates refer to the year 2025.

The Commission will relieve the parties of responding to Evergy's *Motion for Expedited Treatment*. The Commission will also recognize the parties' joint motion as Evergy's voluntary extension of the effective date of the tariff sheet.

THE COMMISSION ORDERS THAT:

1. By agreement of the parties, Evergy's *Motion for Expedited Treatment* is moot. Despite the Commission's order issued on December 23, 2025, directing the parties to respond to Evergy's motion no later than December 30, 2025, the parties are relieved of responding to the motion.

2. Evergy's proposed revised tariff sheet, filed on December 19, 2025, assigned Tracking No. JE-2026-0077, and described as follows:

P.S.C. MO. No. 1
4th Revised Sheet No. 2, Canceling 3rd Revised Sheet No. 2

is voluntarily suspended, with a new effective date of January 18, 2026.

3. This order is effective when issued.
