## ORDER GRANTING REQUESTS TO BE EXCUSED OR TO APPEAR REMOTELY AT THE ON-THE-RECORD

Effective Date: January 5, 2026

The Commission scheduled an on-the-record evidentiary proceeding in this case for January 7, 2026. The Commission further directed that requests for remote appearances of either counsel or witnesses must be filed in advance.

Requests were filed by the parties as follows:

- International Brotherhood of Electrical Workers Local Union No. 1474 (Local 1474)
  - Requested to be excused from the on-the-record as it is not a signatory to the Supplemental Stipulation nor an objector and did not have witnesses in this case.<sup>1</sup>
- Empire District Retired Members & Spouses Association, LLC (EDRA)
  - Requested to be excused from the on-the-record as all issues involving EDRA have been resolved and EDRA takes no position on the Supplemental Stipulation and/or any other global settlement negotiations.<sup>2</sup>
- The Staff of the Commission (Staff)
  - Requested permission for two witnesses to appear remotely:

The Commission finds the requests to be excused and to appear remotely to be reasonable and will grant them.
