## ORDER ON PREHEARING EXHIBIT DISCLOSURE

Issue Date: March 24, 2021

Effective Date: March 24, 2021

On November 2, 2020, Willie J. Harris Jr. filed a complaint with the Commission against Missouri-American Water Company (MAWC). On March 24, 2021, the Commission established a procedural schedule and set an evidentiary hearing for May 4, 2021, to be conducted by telephone and/or video conference.

The procedural schedule calls for the parties to exchange exhibits and file exhibit disclosures in the Commission's electronic filing and information system (EFIS) no later than April 26, 2021. EFIS may be accessed from the Commission's website, <https://psc.mo.gov>. The Commission now provides specific instructions for the exchange and disclosure of exhibits to enable a remote hearing.

### THE COMMISSION ORDERS THAT:

1. Documents included in filings in this case in EFIS may be identified by reference during the hearing to be offered as exhibits.
2. Exchange of documents and filing of an exhibit disclosure under this order does not constitute admission to the record. Proposed exhibits must be referenced during

the evidentiary hearing and specifically offered on the record. Proposed exhibits are subject to evidentiary rulings by the presiding officer.

### **MR. HARRIS'S EXHIBIT DISCLOSURE**

3. No later than April 26, 2021, Mr. Harris shall file in EFIS, as a single, page-numbered submission, copies of all documents he intends to use at an evidentiary hearing in this matter that are not already included in filings in this case (Complainant's exhibit disclosure). Mr. Harris's filing shall be designated confidential. Mr. Harris may make such a filing directly through EFIS, or by mail to:

**Submission by mail must be received by no later than April 26, 2021.**

4. Commission Staff who receive a submission from Mr. Harris, as described above, shall assist in completing the confidential EFIS filing in this case, which will be accessible to all other parties.

### **MAWC'S AND STAFF'S EXHIBIT DISCLOSURES**

5. No later than April 26, 2021, MAWC shall file in EFIS, as a single, page-numbered submission, copies of all documents MAWC intends to offer as exhibits in an evidentiary hearing in this matter that are not already included in any filing in this case (MAWC's exhibit disclosure). MAWC's filing shall be designated confidential as appropriate.

6. No later than April 29, 2021, MAWC shall file in EFIS a statement of MAWC's efforts to deliver a copy of MAWC's exhibit disclosure by U.S. Mail and/or courier service to Mr. Harris's address of record by no later than April 26, 2021. Such a filing shall include a confirmation of delivery, if available.

7. No later than April 26, 2021, Staff shall file in EFIS, as a single page-numbered submission, copies of all documents Staff intends to offer as exhibits in an evidentiary hearing in this matter that are not already included in any filing in this case (Staff's exhibit disclosure). Staff's filing shall be designated confidential as appropriate.

8. No later than April 29, 2021, Staff shall file in EFIS a statement of Staff's efforts to deliver a copy of Staff's exhibit disclosure by U.S. Mail and/or courier service to Mr. Harris's address of record by no later than April 26, 2021. Such a filing shall include a confirmation of delivery, if available.

9. The purpose of the filing of such exhibit disclosures is to provide secure files that can be consulted by the Commission and the parties for the purpose of disclosing exhibits and conducting a hearing. **Delivery of paper copies of such disclosures to Mr. Harris is intended to facilitate Mr. Harris's participation in the hearing. As such, Mr. Harris shall anticipate and accept such deliveries from MAWC and Staff.**

10. The Commission's data center shall mail a copy of this order to Mr. Harris by U.S. Mail addressed to Mr. Harris's address of record.

11. This order shall be effective when issued.
