NOTICE OF DEFICIENCY

Issue Date: January 8, 2026

On December 31, 2025, Missouri-American Water Company (MAWC), filed a *Water Territorial Agreement between Missouri-American Water Company and Johnson County PWSD #3*. MAWC did not include any explanation of why it was filing a territorial agreement or what it wanted the Commission to do with the territorial agreement.

Section 247.172 RSMo, governs territorial agreements involving public water supply districts. Commission approval of a territorial agreement requires an application and an evidentiary hearing (with an exception for stipulation and agreements submitted by all parties). The territorial agreement and application for approval should be filed as a new case and not within this case.

The Commission will not act on the territorial agreement between MAWC and Johnson County PWSD #3 until this deficiency is corrected.
