On June 1, 2021, the Empire District Electric Company filed its Verified Winter Storm Uri AAO Application requesting an accounting authority order regarding costs incurred during the extreme weather event of February of 2021. On June 7, 2021, Midwest Energy Consumer's Group (MECG) filed an application to intervene. MECG's application contends allowing MECG to intervene will serve the public interest by assisting the record development in this case. More than 10 days have passed since MECG applied to intervene.
