## ORDER DIRECTING RESPONSES

On December 10, 2025, the Staff of the Commission (Staff) filed its recommendation and memorandum regarding Summit Natural Gas of Missouri, Inc.'s (SNGMO's) Actual Cost Adjustment filing. Staff expressed some concerns, comments, and recommendations.

On January 12, 2026, SNGMO filed its *Response to Staff's Recommendation and Memorandum* (Response). The Response addressed Staff's concerns, comments, and recommendations, but also recommended a change to the ACA balance regarding the Gallatin Division. The Response proposes that over-recovery dollars as of September 2023 be attributed to the Winter Storm Uri gas costs instead of to reduce the regular ACA gas costs for Gallatin.

The Commission will direct Staff to respond and set a date for other responses.

### THE COMMISSION ORDERS THAT:

1. No later than January 26, 2026, Staff shall file a response to SNGMO's Response.
2. Any other responses to SNGMO's Response shall be filed no later than January 26, 2026.
3. This order shall be effective when issued.
