ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On January 7, 2026, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of authority to provide interexchange telecommunications and non-switched local exchange (IXC) service in Missouri of Harcourt Telco, LLC., d/b/a Maverix.net, Inc. (“Company”).

Staff’s motion states that the Company was administratively dissolved or revoked in 2001. Subsequently, Staff reports, the Company has not filed annual reports or Statement of Revenues as required by Commission rules.

The Commission need not hold a hearing, if, after proper notice, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff’s motion is received, the Commission may cancel the certificate based on Staff’s motion.²

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
