## ORDER RECOGNIZING NAME CHANGE

Issue Date: January 20, 2026

Effective Date: January 30, 2026

On January 7, 2026, the Commission received a request from Consolidated Communications Enterprise Services, LLC d/b/a Consolidated Communications to recognize its name change to Fidium Enterprise Services, LLC d/b/a Consolidated Communications.<sup>1</sup> The company also requested the Commission approve the submitted adoption notices and revised tariff title sheets, assigned Tracking Nos. JX-2026-0090, JX-2026-0091, and JX-2026-0092. The submitted adoption notices and revised tariff title sheets in Tracking Nos. JX-2026-0090, JX-2026-0091 all have an effective date of February 6, 2026. Consolidated Communications stated it withdraws PSC MO. No. 4 (wireless termination tariff), via Tracking No. JX-2026-0092, as there are no customers served by this tariff.

The Commission has reviewed the filings and 20 CSR 4240-28.011(2) and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change of Consolidated

Communications Enterprise Services, LLC d/b/a Consolidated Communications to Fidium Enterprise Services, LLC d/b/a Consolidated Communications. The Commission will also approve the withdrawal of Consolidated Communications' wireless termination tariff, PSC MO. No. 4, assigned Tracking No. JX-2026-0092.

The Commission finds it reasonable for this order to become effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the name change of Consolidated Communications Enterprise Services, LLC d/b/a Consolidated Communications to Fidium Enterprise Services, LLC d/b/a Consolidated Communications.

2. The Commission approves the adoption notices and revised tariff title sheets, assigned Tracking Nos. JX-2026-0090 and JX-2026-0091, to become effective on February 6, 2026, as follows:

3. The Commission approves the cancellation of Consolidated Communications' wireless termination tariff, PSC MO. No. 4, assigned Tracking No. JX-2026-0092, to become effective on June 1, 2026.

4. This order shall become effective on January 30, 2026.
