## ORDER GRANTING EXTENSION AND SUSPENDING TARIFF

Issue Date: January 20, 2026

Effective Date: January 20, 2026

On January 5, 2026, Everyg Metro, Inc. d/b/a Everyg Missouri Metro and Everyg Missouri West, Inc. d/b/a Everyg Missouri West (collectively “Everyg”) filed tariff sheets to allow its customers to opt out of Time of Use (TOU) rates. Those tariff sheets bear an effective date of February 4, 2026. The Commission directed its Staff (Staff) to file a tariff report and recommendation no later than January 16, 2026.

On January 16, 2026, Staff filed a motion requesting an additional ten days for tile its report and recommendation.

Unless the Commission takes action to suspend the tariff sheets, Tracking Nos. JE-2026-0081 and JE-2026-0082, they will go into effect when their suspension period ends on February 4, 2026. Therefore, the Commission will suspend those tariff sheets to allow time for Staff to complete its report and recommendation and conduct any necessary discovery.

**THE COMMISSION ORDERS THAT:**

1. Staff's motion for an extension is granted. Shaff shall file a tariff report and recommendation no later than January 26, 2026.
2. The tariff sheets submitted by Evergy on January 5, 2025, as substituted January 16, 2026, and assigned Tracking Nos. JE-2026-0081 and JE-2026-0082, are suspended until February 16, 2026.
3. This order shall be effective when issued.
