ORDER RECOGNIZING NAME CHANGE

Issue Date: January 21, 2026

Effective Date: January 31, 2026

On January 6, 2026, the Commission received a request from FDF Communications Co. to recognize its adoption of the fictitious name BPS Fiber.¹ FDF Communications Co. was issued an Interconnected Voice over Internet Protocol (IVoIP) registration in Case No. DA-2015-0001.

The Commission has reviewed the filings and 20 CSR 4240-28.011(2) and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change.

The Commission finds it reasonable for this order to become effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of FDF Communications Co. to FDF Communications Co. d/b/a BPS Fiber.
2. This order shall become effective on January 31, 2026.

¹ The Commission notes that this application was divided into three cases – the above-captioned case addresses the IVoIP registration name change; Case No. IN-2026-0167 addresses the ILEC certificate name change; and Case No. XN-2026-0168 addresses the IXC certificate name change.

3. This case shall close on February 1, 2026.
