## **ORDER DIRECTING STAFF RECOMMENDATION ON SUBSTITUTE TARIFF SHEET**

On December 1, 2025, Union Electric Company d/b/a Ameren Missouri filed a tariff sheet, with supporting testimony, to adjust the rate of its Missouri Energy Efficiency Investment Act (MEEIA) Energy Efficiency Investment Charge (EEIC). The tariff sheet bore an effective date of February 1, 2026, and has been assigned Tracking No. JE-2026-0075.

On January 9, 2026, the Commission approved the tariff sheet in its *Order Approving Rider Energy Efficiency Investment Charge Tariff Sheet*.

On January 21, 2026, Ameren Missouri filed a substitute tariff sheet to correct a figure.

The Commission will direct its Staff to file a recommendation, on an expedited basis, as to the substitute tariff sheet.

### **THE COMMISSION ORDERS THAT:**

1. No later than 12:00 p.m. on January 23, 2026, Staff shall file a recommendation regarding Ameren Missouri’s substitute tariff sheet filed January 22, 2026 (Tracking No. JE-2026-0075).
2. Any party wishing to respond to Ameren Missouri’s tariff sheet filing or to Staff’s recommendation shall do so no later than 12:00 p.m. on January 23, 2026.

3. This order shall be effective when issued.

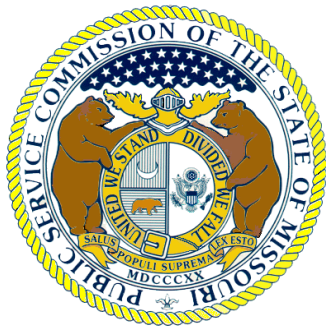
