On April 1, 2021, The Empire District Electric Company d/b/a Liberty asked the Commission to grant it variances from certain requirements of the Commission's Integrated Resource Planning Rule, 20 CSR 4240-22.030 and 20 CSR 4240-20.094. The Commission will allow time for potentially interested parties to apply to intervene, and will order a Staff Recommendation.

### **THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall provide a copy of this order to all parties to Liberty's previous IRP case, EO-2019-0049.
2. Any application to intervene shall be filed no later than April 26, 2021.
3. The Staff of the Commission shall file a Recommendation or, in the alternative, a Status Report stating when it plans to file its Recommendation, no later than April 26, 2020.
4. This order shall become effective when issued.
