NOTICE THAT TARIFF WILL BE ALLOWED TO GO INTO EFFECT BY OPERATION OF LAW

Issue Date: February 4, 2026

On November 12, 2025,¹ Union Electric Company d/b/a Ameren Missouri filed a tariff sheet to establish rates for Phase 3 of its Renewable Solutions Program (RSP). The tariff sheet bore an effective date of December 12, and was assigned Tracking No. JE-2026-0068. At the direction of the Commission, on November 24, the Staff of the Commission (Staff) filed its *Report and Recommendation* on the tariff sheet, recommending that the Commission approve the rate schedule set out in the tariff sheet but suspend the tariff sheet itself.

On December 2, Ameren Missouri extended the effective date of the tariff sheet to December 19. On December 17, Ameren Missouri further extended the effective date of the tariff sheet to December 24.

On December 23, the Commission suspended the tariff sheet further, extending the effective date to December 31. On December 30, the Commission again further suspended the effective date of the tariff sheet, this time to January 24, 2026.

¹ Unless otherwise noted, all dates refer to the year 2025.

On January 15, 2026, Ameren Missouri filed a *Motion for Determination on the Pleadings* and, on January 16, 2026, extended the effective date of the tariff sheet to February 15, 2026. On January 26, 2026, Staff filed its *Response to Ameren Missouri's Motion for Determination on the Pleadings / Cross Motion for Determination on the Pleadings*. On January 30, 2026, Ameren Missouri filed a *Reply to Commission Staff*.

The Commission has considered all pleadings filed on and after November 12. The Commission will allow Ameren Missouri's proposed tariff sheet, filed on November 12 and assigned Tracking No. JE-2026-0068, to take effect by operation of law on February 15, 2026. The tariff sheet is described as follows:
