ORDER GIVING NOTICE, SETTING A DEADLINE TO INTERVENE, SETTING A DEADLINE TO RESPOND TO THE TEST YEAR, AND DIRECTING A PROPOSED SCHEDULE

Effective Date: February 9, 2026

Evergy Metro, Inc. d/b/a Evergy Missouri Metro submitted tariff sheets on February 6, 2026, to produce a net increase in its electric base rates of approximately \$137.9 million. Evergy Missouri Metro proposes a test year of the twelve months ending June 30, 2025, and further proposes the test year be trued-up through June 30, 2026.

The Commission will provide notice of Evergy Missouri Metro's application, provide time for intervention, and set a deadline to respond to the proposed test year. The Commission will also order a joint proposed procedural schedule that includes the following:

- Submission of List of Issues and Position Statements at least ten days in advance of the hearing;
- At least one settlement conference;
- Cut-off dates for service of discovery requests and responses;
- Dates for discovery conferences;
- Allowance for ten business days for transcript preparation;
- Local and evidentiary hearings.

Any request for expedited hearing transcripts must be made before the procedural schedule is established.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve a copy of this order upon the county commission of each county within Evergy Missouri Metro's service area.
2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing Evergy Missouri Metro's service area and to the news media serving therein.
3. Applications to intervene shall be filed no later than February 27, 2026, with the Secretary of the Missouri Public Service Commission or in the Commission's Electronic Filing and Information System.
4. Any party wishing to respond to Evergy Missouri Metro's proposed test year shall do so no later than March 6, 2026.
5. No later than March 6, 2026, the parties shall submit a joint proposed procedural schedule as described in this order. The Staff of the Commission shall coordinate and file the joint proposed procedural schedule.
6. This order shall be effective when issued.
