ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: February 10, 2026

Effective Date: February 20, 2026

The Commission issued its *Report and Order* in this case on January 14, 2026.¹ That *Report and Order* approved the *Non-Unanimous Global Stipulation and Agreement* and the *Supplemental Stipulation and Agreement* (Supplemental Stipulation). Paragraph 2 of the Supplemental Stipulation stated the intention of the signatories was that certain tariff changes would take effect as compliance tariffs – separate from the rate changes that must first meet certain customer service and billing metrics.

On January 21, The Empire District Electric Company d/b/a Liberty filed tariff sheets purporting to be in compliance with Paragraph 2 of the Supplemental Stipulation and the *Report and Order*, which were assigned Tracking No. JE-2026-0096. Liberty explained that none of the submitted tariff sheets impact rates or charges. The tariff sheets were submitted with an effective date of February 20.

Liberty continued to work with Staff after the sheets were submitted; and, on February 6, Liberty made a substitute filing regarding several of the tariff sheets.

The Commission ordered its Staff (Staff) to file a recommendation regarding the compliance tariff sheets and set a time for any other party to respond. Staff filed its recommendation on February 9. Staff recommended that the Commission approve the tariff sheets as substituted on February 6. No other party filed a response.

Upon reviewing the pleadings, the Commission finds Liberty's proposed tariff sheets comply with the Commission's *Report and Order* and will approve them. To enable the tariff sheets to become effective on the date requested by Liberty, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets assigned Tracking No. JE-2026-0096, filed on January 21 and as supplemented and substituted on February 6, are approved to become effective on February 20. The specific tariff sheets approved are as follows:
