On February 11, 2026, Central Missouri Electric Cooperative, Inc., (CMEC) and Evergy Missouri West, Inc., (Evergy) filed a Joint Status Report. CMEC and Evergy state that the parties are attempting to negotiate their differences, and that they need additional time to finalize maps and legal descriptions for the affected property. CMEC and Evergy ask that the Commission order CMEC and Evergy to file a stipulation and agreement or a status report on or before April 24, 2026, and June 26, 2026.

The Commission finds the request reasonable, and it will grant it.

**THE COMMISSION ORDERS THAT:**

1. The parties shall file a stipulation or a status report no later than April 24, 2026.
2. This order shall be effective when issued.
