**ORDER SHORTENING TIME FOR RESPONSES TO MOTION TO  
AMEND STIPULATION AND AGREEMENT**

On February 27, 2026, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively “Evergy”), the Commission’s Staff (Staff), Renew Missouri, and the Office of the Public Counsel filed their *Joint Motion to Amend Non-Unanimous Stipulation and Agreement*. The motion asks to amend the approved stipulation and agreement to allow Evergy to reallocate funds from one program to another.

The motion also asks that the Commission rule on the motion within 30 days. Not all parties joined the motion. Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless another response time is established by the Commission. The Commission finds it appropriate to shorten the response period in this instance. Therefore, the Commission will shorten the time for responses.

**THE COMMISSION ORDERS THAT:**

1. Any responses to the Joint Motion to Amend Non-Unanimous Stipulation and Agreement must be filed no later than March 6, 2026
2. This order shall be effective when issued.
