ORDER GRANTING MOTION FOR EXTENSION

On January 28, 2026, Evergy Metro, Inc., d/b/a Evergy Missouri Metro and Evergy West, Inc. d/b/a Evergy Missouri West (collectively, Evergy) filed Motions to Open New Dockets for Integrated Resource Plan Updates. On February 27, 2026, Evergy filed Motions for Extensions.

Evergy asks for an extension of time from April 1, 2026 to June 15, 2026 to make their filings. Evergy explains that this extension is necessary to allow time for incorporating key changes into the Companies’ modeling. Evergy represents that the Commission’s Staff and the Office of the Public Counsel do not object.

The Commission finds the request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The motion for extension is granted.
2. Evergy shall file their annual update filings no later than June 15, 2026.

3. This order shall become effective when issued.
