On March 5, 2026, Spire Missouri Inc. d/b/a Spire filed the above-referenced tariff. Spire did so to comply with the Commission’s March 5, 2026 Order Approving Infrastructure System Replacement Surcharge. The tariff bears an effective date of April 4, 2026.
