ORDER CANCELLING REGISTRATION TO PROVIDE IVOIP SERVICES

Issue Date: March 18, 2026

Effective Date: March 28, 2026

On March 5, 2026, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the registration of MJ2 IP, LLC to provide Interconnected Voice over Internet Protocol (IVoIP) telecommunications service. The Commission granted MJ2 IP, LLC (Company) a certificate to provide IVoIP telecommunications service in Case No. DA-2020-0142.

Staff's motion states that MJ2 IP, LLC filed Articles of Cancellation with the Missouri Secretary of State's Office in 2023. The motion also states that the Company failed to file an annual report or statements of revenue for calendar year 2024; and failed to pay the Commission assessment for fiscal year 2026.

The requirements of telecommunications companies under Sections 392.210 and 392.390, RSMo, include filing an annual report and statement of revenue.

The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing..." The Commission issued notice and allowed time to request a hearing. No responses were received.

Based on Staff's motion, the Company's failure to file a statement of revenue or an annual report as required by rule, because the Company filed Articles of Cancellation, and because the Company has not requested a hearing or otherwise responded, the Commission finds that the registration of service authority granted to MJ2 IP, LLC shall be cancelled.

THE COMMISSION ORDERS THAT:

1. The registration of service authority issued in Case No. DA-2020-0142 to MJ2 IP, LLC to provide IVoIP telecommunications services in the state of Missouri is cancelled.
2. This order shall become effective on March 28, 2026.
3. This case shall be closed on March 29, 2026.
