ORDER CANCELLING REGISTRATION

Issue Date: March 19, 2026

Effective Date: March 29, 2026

On March 5, 2026,¹ the Staff of the Commission (Staff) filed a motion requesting the Commission cancel the certificate of Nexogy, Inc. to provide Interconnected Voice over Internet Protocol (IVoIP) telecommunications service. Due to Nexogy's responsive filing, the Commission finds Staff's motion to be moot and will cancel the registration at the request of Nexogy, as below.

On March 6, Nexogy filed a letter notifying the Commission that it wished to cancel its IVoIP registration in Missouri. Nexogy's letter stated it does not currently provide any service to customers in Missouri. Nexogy was granted an IVoIP registration in Case No. DA-2020-0071.

Commission Rule 20 CSR 4240-28.011(3) permits a company to cancel a registration by filing a letter signed by a company official that identifies when and which certificate to cancel. Based on the request of Nexogy, the Commission finds that the registration granted to it to provide IVoIP telecommunications services in Missouri shall be cancelled.

THE COMMISSION ORDERS THAT:

1. The registration to provide IVoIP telecommunications services, granted to Nexogy, Inc. in Case No. DA-2020-0071, is cancelled.
2. This order shall become effective on March 29, 2026.
3. This case shall be closed on March 30, 2026.
