## ORDER RECOGNIZING NAME CHANGE

Issue Date: November 21, 2017

Effective Date: December 3, 2017

On November 3, 2017, Cincinnati Bell Any Distance Inc. filed a letter informing the Commission that it has changed the name by which it provides telecommunications service in Missouri to CBTS Technology Solutions, LLC.

Staff filed a recommendation on November 15, 2017, advising the Commission that the notice of name change complies with the Commission's requirements for a name change, and recommending that the Commission allow the related tariffs filed by the company to go into effect by approval or operation of law. No one has opposed the name change.

The Commission has reviewed the notice of name change and Staff's recommendation. The Commission finds that the name change should be recognized. The Commission notes that CBTS Technology Solutions, LLC's tariff adoption notice will become effective by operation of law on December 3, 2017.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the change of name of Cincinnati Bell Any Distance Inc. to CBTS Technology Solutions, LLC.

2. This order shall be effective December 3, 2017.
3. This file shall be closed on December 4, 2017.
