On March 10, 2026, Spectrum Mid-America, LLC, pursuant to Section 67.2679.7, RSMo 2016, filed a Notice of Change Application seeking to expand video service to the following political subdivisions:

extent the video service provider or an affiliate did not otherwise possess a valid authorization to occupy the public rights-of-way.

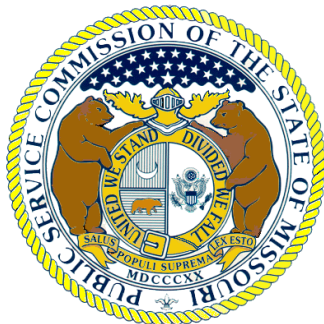
