**Status Report and Motion**

COMES NOW, Show Me Ethanol, (“SME”) and on behalf of the parties, states:

1. On March 6, 2026, SME filed a status report in this case asking for additional time to investigate the issues in this case and asked for additional time to file a status report or proposed procedural schedule no later than April 3<sup>rd</sup>.
2. The Commission granted an extension and ordered its Staff to file a proposed procedural schedule on behalf of the parties no later than April 3, 2026.
3. In the interim, SME has engaged third party consultants to aid in investigating the cause of the issues that are the basis for this complaint and has begun discussions with Evergy about monitoring equipment that Evergy has previously used on-site and whether it would be willing to perform additional monitoring with certain technical parameters identified by the third-party consultants. These discussions are on-going and when the monitoring equipment is installed, it will likely take additional time before results or information is available. SME intends to keep the interested parties apprised of the progress on this effort.
4. At this time, SME asks the Commission to accept this status report and moves the Commission permit parties additional time beyond April 3<sup>rd</sup> to May 4<sup>th</sup> to file either a status report or procedural schedule.

5. SME also agrees that Staff shall be relieved of the duty of filing further status reports unless the Commission so orders.
