**ORDER APPROVING TARIFF REVISIONS**

Issue Date: April 20, 2026

Effective Date: May 1, 2026

On December 31, 2025, Liberty Utilities (Missouri Water) LLC d/b/a Liberty filed tariff revisions, Tracking Nos. JW-2026-0079 and JS-2026-0080, containing revised maps and legal descriptions to comply with the Commission’s *Order Approving Stipulation and Agreement*. Those tariff revisions were set to become effective on March 1, 2026. The Staff of the Commission (Staff) and Liberty Utilities (Missouri Water) LLC d/b/a Liberty requested several extensions to identify and correct errors. Liberty voluntarily extended the effective date for its tariff revisions to May 1, 2026.

On April 6, 2026, Liberty withdrew some sheets from tariff revision Tracking No. JW-2026-0079 and filed a substitute tariff revision that same day. It also filed substitute tariff sheets in Tracking No. JS-2026-0080 on April 6, 2026. Sheets were again substituted in Tracking No. JW-2026-0079 on April 13, 2026.

On April 17, 2026, the Staff of the Commission filed a recommendation that the Commission approve the tariff revisions as substituted. Therefore, the Commission will approve the tariff revisions as substituted. So that the tariff revisions and order become effective on the requested effective date, the Commission finds it reasonable to make this order effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The tariff revision assigned Tracking No. JW-2026-0179, with sheets withdrawn and substituted is approved to become effective on May 1, 2026. The specific tariff sheets approved are enumerated in *Staff Recommendation to Approve Tariffs* filed April 17, 2026.

2. The tariff revision assigned Tracking No. JS-2026-0180, as substituted is approved to become effective on May 1, 2026. The specific tariff sheets approved are enumerated in *Staff Recommendation to Approve Tariffs* filed April 17, 2026.

3. This order shall be effective May 1, 2026.
