ORDER OF CORRECTION

The Commission is correcting its *Report and Order Approving Stipulation and Agreement and Approving Designated Service Boundaries*, issued April 15, 2026, but not effective until April 25, 2026. This order is issued *nunc pro tunc* under Commission Rule 20 CSR 4240-2.160(4), to correct Findings of Fact Paragraph 5, regarding the franchise agreement granted by the City of Ozark to White River Electric Cooperative, Inc.

Paragraph 5 stated as follows, “On January 6, 2025, the Board of Aldermen for the City of Ozark approved a franchise agreement allowing White River to provide exclusive retail electric service within the city limits of Ozark, replacing the franchise agreement it had with Liberty.” The correction is to specify that the franchise agreement is non-exclusive and not a replacement for the franchise agreement the city has with The Empire District Electric Company d/b/a Liberty.

THE COMMISSION ORDERS THAT:

1. The Commission’s *Report and Order Approving Stipulation and Agreement and Approving Designated Service Boundaries*, issued April 15, 2026, is corrected *nunc pro tunc*, under the heading **Findings of Fact**, to read as follows:

5. On January 6, 2025, the Board of Aldermen for the City of Ozark approved a non-exclusive franchise agreement allowing White River to provide retail electric service within the city limits of Ozark.

2. This order shall be effective when issued.
