ORDER CANCELING REGISTRATION

Issue Date: April 23, 2026

Effective Date: May 3, 2026

On April 8, 2026, Everstream Solutions LLC filed a letter notifying the Commission that it no longer wished to retain its certificate of authority to provide interexchange and non-switched local exchange telecommunications services in Missouri. The letter stated that Everstream Solutions no longer has any customers, facilities, or operations in Missouri. Everstream Solutions was granted its certificate of authority in Case No. XA-2019-0350. Everstream Solutions does not have a currently effective tariff.

Commission Rule 20 CSR 4240-28.011(3) permits a company to cancel a certificate of service authority by filing a letter signed by a company official that identifies when and which certificate and any applicable tariffs to cancel. Based on the request of Everstream Solutions, the Commission finds that the certificate of authority granted to it to provide interexchange and non-switched local exchange telecommunications services in Missouri shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide interexchange and non-switched local exchange telecommunications services, granted to Everstream Solutions LLC in Case No. XA-2019-0350, is canceled.
2. This order shall become effective on May 3, 2026.
3. This case shall be closed on May 4, 2026.
