## ORDER EXTENDING TIME FOR REPORT

This case involves an investigation of a natural gas pipeline incident that occurred on January 3, 2025, in the Glendale area of St. Louis, Missouri, which is in the service area of Spire Missouri Inc. d/b/a Spire. The Staff of the Commission (Staff) has been ordered to file an investigative report, which due date has been previously extended.

On April 27, 2026, the Staff of the Commission (Staff) filed a status report and requested additional time to file its investigative report. Staff requested an extension to file its investigative report to June 12, 2026.

The Commission finds the request for an extension to be reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff's request for an extension is granted.
2. Staff's investigative report, or a report on the status of Staff's investigation, shall be filed no later than June 12, 2026.
3. This order shall be effective when issued.
