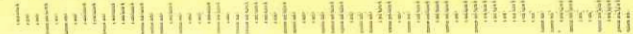

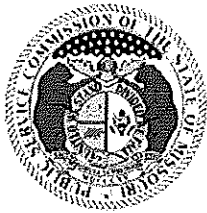


or objection to Staff's motion is received, the Commission may revoke the telecommunications certificate based on Staff's motion.




