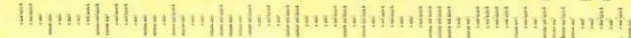

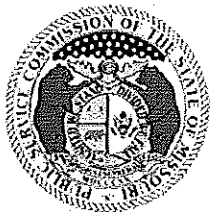


hearing..." The Commission issued notice and allowed time to request a hearing. No responses were received.

Based on Staff's motion, the Company's failure to file a Statement of Revenue or an annual report as required by rule, and because the Company has not requested a hearing or otherwise responded, the Commission finds that the certificate of service authority granted to Working Assets Funding Service Inc. d/b/a Credo Long Distance shall be cancelled.

THE COMMISSION ORDERS THAT:

1. The certificate of service authority issued in Case No. TA-93-159 to Working Assets Funding Service Inc. d/b/a Credo Long Distance to resell interexchange telecommunications services in the state of Missouri is cancelled.
2. This order shall become effective on March 28, 2026.
3. This case shall be closed on March 29, 2026.




