**ORDER SETTING LOCAL PUBLIC HEARINGS**

Issue Date: May 7, 2026

Effective Date: May 7, 2026

Evergy Metro, Inc. d/b/a Evergy Missouri Metro submitted tariff sheets on February 6, 2026, to produce an annual increase in its electric base rates of approximately \$137.9 million. On March 18, 2026, the Commission issued a procedural schedule, but did not set local public hearings.

On March 31, 2026, Evergy Missouri Metro, the Staff of the Commission (Staff), and the Office of the Public Counsel (Public Counsel) filed a proposed local public hearing schedule with locations. No party has objected to that schedule and the Commission will adopt it with a location modification.

**THE COMMISSION ORDERS THAT:**

1. The Commission’s Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of each local public hearing. Comments to the Commission from the public will begin at the conclusion of the question and answer session.

2. Evergy Missouri Metro, Staff, and Public Counsel shall make a representative available to address substantive issues during the question-and-answer sessions. Any other party may also choose to have a representative present.

3. Any person may participate at any of the hearings but are encouraged to attend the hearing closest to their service area for the most relevant information. Comments at each hearing may be limited to three minutes per person.

8. Comments may also be submitted to the Commission in writing by mail to the Missouri Public Service Commission, P.O. When submitting comments please reference Case No. ER-2026-0143.

9. No later than ten days before the local public hearings, Evergy Missouri Metro shall provide notice of the hearings to each of its customers. The parties shall jointly file language to include in the local public hearing notice no later than May 11, 2026.

10. So that everyone has a chance to speak, comments at the hearings may be limited to three minutes per person.

11. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the media and the General Assembly representing customers in Evergy Missouri Metro's electric service areas.

12. The Commission's Data Center shall provide a copy of this order to the county commission for each county in Evergy Missouri Metro's service area.

13. This order shall be effective when issued.
