**ORDER GRANTING MOTION TO EXTEND SUSPENSION OF CASE
PROCEEDINGS AND DIRECTING A FURTHER STATUS REPORT**

The case proceedings in this docket were ordered suspended on March 24, 2026,¹ at the request of PCI, Inc. (PCI). In granting the suspension, the Commission also ordered PCI to file a status report.

On May 5, PCI timely filed its *Status Report and Motion to Extend Suspension of Proceedings* (Motion). The Motion states that Staff and PCI have continued discussions regarding the present case, and specifically that PCI has encountered obstacles in resolving this matter. The Motion requests that the Commission continue its suspension of the case and order PCI to file a further status report regarding this matter in June. The Motion states that Staff does not object to the request.

The Commission finds the request reasonable and will grant it.
