ORDER GRANTING EXTENSION OF TIME

On March 5, 2026, Brett Felber and Lisa Lambert (collectively, Complainants) filed a complaint against Ameren Missouri. The Commission ordered its Staff to file a report no later than May 11, 2026.

On May 11, 2026, Staff filed a Motion for Clarification and Extension, which the Commission granted. In its motion, Staff requested that Complainants file a supplemental pleading and supporting documents specifically identifying the amount in controversy, and clarifying any outstanding issues properly before the Commission. Staff also requested an additional 30 days to file its' report after Complainants respond.

Complainants have filed four responses: two on May 11, 2026, and two again on May 12, 2026. Complainants' first response indicates no objection to granting an

additional 30 days for Staff to file its report.

The Commission will now order its Staff to file its report.

THE COMMISSION ORDERS THAT:

1. Staff shall file its' report no later than June 12, 2026.
2. This order shall be effective when issued.
