**NOTICE CLOSING CASE AND NOTICE TO COMPLAINANT THAT FURTHER
ABUSE OF THE COMMISSION’S FILING SYSTEM WILL RESULT IN
RESTRICTIONS OF THE ABILITY TO DIRECTLY USE THE SYSTEM TO FILE
CASES**

Issue Date: May 22, 2026

Section 386.550 RSMo, states that in all collateral actions or proceedings Commission orders that are final shall be conclusive. Latrell Germany’s most recent complaint reasserts claims from Case No. GC-2026-0278. The reassertion of claims previously adjudicated before the Commission outside of the appellate process is not permitted under Missouri law and may be stricken under the Commission’s regulations, specifically Commission Rule 20 CSR 4240-2.070(7).

After the dismissal of Germany’s complaints and denial of rehearing, Germany filed the same document multiple times under new case numbers, which is not the correct way to address her disagreement with the Commission’s dismissal. By having filed timely motions for rehearing, which were denied, Germany has apparently fulfilled the necessary requirements to appeal the Commission’s order to an appropriate appellate court, normally the next step in the process.

Germany is hereby notified that the continued refiling of her previous complaint is an abuse of the pro-se filing process available in the Commission's Electronic Filing and Information System (EFIS) and, if continued, will result in the Commission restricting her direct EFIS filing privileges.

The Commission notes that other than this notice to complainant it does not need to take any action regarding this case and it shall be closed.
