**EVERGY MISSOURI METRO’S AND EVERGY MISSOURI WEST’S
REQUEST FOR COMMISSION ORDER RECOGNIZING PARTIES**

COMES NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”)(collectively “Evergy” or the “Companies”) and, for their *Request for Commission Order Recognizing Parties* (“Request”), state as follows:

1. The Companies filed their respective Integrated Resource Plan (“IRP”) Annual Updates on May 7, 2026.¹
2. Currently, an IRP Annual Update stakeholder meeting is scheduled to take place on Friday, June 26, 2026, at 2:30 p.m.
3. At this time, the Companies request that the Missouri Public Service Commission (“Commission”) issue an order recognizing the parties from the Companies’ last IRP dockets (EO-2025-0250 and EO-2025-0151) as parties to the current dockets in order to facilitate the planned IRP Annual Update stakeholder meeting referenced above.

WHEREFORE, Evergy Missouri Metro and Evergy Missouri West respectfully request that the Commission issue an order recognizing parties.
