ORDER GRANTING MOTION FOR LEAVE TO UPDATE PETITION

On March 3, 2026,¹ Missouri-American Water Company (MAWC) filed a petition to change its water and sewer infrastructure rate adjustments (WSIRAs).

Pursuant to Commission Rule 20 CSR 4240-10.185(3)(C), to be considered in the report of the Staff of the Commission (Staff), any updates to the petition must be filed no later than 60 days from the date the petition was filed – making the deadline in this case May 2.

On May 13, MAWC filed its *Motion for Leave to Update Petition Out of Time* (Motion). The Motion requests that MAWC be permitted to provide the update at issue subsequent to May 2.

The Motion indicates that MAWC received notification from Staff that MAWC’s petition required updating. The Motion explains that it failed to update its petition with the information requested by May 2 because its April books were not yet closed by that date, making such updating not possible by the 60-day deadline. The Motion indicates that Staff does not oppose the motion, and no other parties have responded to the motion.

The Commission finds good cause to grant MAWC's unopposed motion.

1. The *Motion for Leave to Update Petition Out of Time* is granted.
