ORDER SUSPENDING TARIFF

On May 28, 2026, Missouri-American Water Company (Missouri-American) filed applications initiating two Certificate of Convenience and Necessity (CCN) cases to define its water and sewer service areas pursuant to a Commission approved stipulation. The applications included tariff sheets to define service areas and legal descriptions. Those tariff sheets bear June 27, 2026, effective dates.

On June 1, 2026, the Commission asked its Staff (Staff) whether those tariff sheets should be suspended pending a determination in the CCN cases. On June 4, 2026, Staff responded stating that the tariff sheets should be suspended.

Therefore, the Commission will suspend Missouri-American’s tariff sheets pending a resolution of the CCN cases.

THE COMMISSION ORDERS THAT:

1. The tariff sheets submitted by Missouri-American on May 28, 2026, assigned Tracking Nos. JW-2026-0149 and JS-2026-0150, are suspended until December 17, 2026, or until further order of the Commission.
2. This order is effective when issued.
