SUPPLEMENT

Dear Secretary Dippell:

On May 20, 2026, K.L.M. Telephone Company, LLC (formerly K.L.M. Telephone Company) ("K.L.M. Telephone") filed a notice regarding its intent to conduct business in Missouri under the fictitious name "Socket Fiber". By this Supplement, K.L.M. Telephone provides additional information identified in the Staff Notice filed on June 2, 2026.

First, K.L.M. Telephone will continue to comply with all applicable laws and regulations relating to its designation as an eligible telecommunications carrier ("ETC"). The addition of the fictitious name "Socket Fiber" will have no impact on the ability for K.L.M. Telephone to comply with its obligations as an ETC.

Second, K.L.M. Telephone provides as **Attachment A** the sample notice to customers regarding the planned fictitious name "Socket Fiber".¹ As noted in Attachment A, K.L.M. Telephone also clarifies that it intends to commence use of the "Socket Fiber" fictitious

¹ The Notice also advised of a change in corporate form from a Missouri corporation to a Missouri limited liability company that resulted in a legal name change from "K.L.M. Telephone Company" to "K.L.M. Telephone Company, LLC" (the "Conversion"). Separately notifying customers of the minor change to add "LLC" to the company's legal name may cause confusion. Therefore, notice to customers of the change in name resulting from the Conversion should not be necessary.
