ORDER DIRECTING STAFF TO FILE PROCEDURAL SCHEDULE

On February 24, 2021, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively “Evergy”) filed its application requesting the Commission approve transportation electrification pilot programs, pursuant to Section 393.1610, RSMo (Cum. Supp. 2020). In addition, Evergy filed associated tariff sheets.¹ Evergy’s application also requests variance of Commission rules prohibiting certain promotional practices and authority to defer costs associated with the pilot programs as a regulatory asset for consideration in future rate cases. Finally, Evergy requests the Commission find that the proposed “Clean Charge Network” expansion plan is “prudent from a decisional perspective.”²

On March 29, 2021, Staff filed its recommendation and recommended the Commission reject the tariff sheets or, alternatively, order the parties to submit a proposed procedural schedule. On April 14, 2021, Evergy filed its response to Staff’s recommendation and requested that, rather than denying the tariffs, the Commission

adopt Staff's proposal that the Commission direct the parties to develop and submit a proposed procedural schedule. Evergy's response references the procedure recently used by the Commission in File No. ET-2020-0390 to develop a procedural schedule.³ In addition, Evergy's response offers a proposed schedule, which includes a three-day hearing.

The Commission will direct the parties to consult with Staff to develop a procedural schedule and will direct Staff to file a joint proposed procedural schedule. The parties may review the Commission's hearings calendar, posted at the Commission's website at <https://psc.mo.gov>, to identify conflicts.

The proposed schedule shall specify whether the parties will pre-file testimony and, if so, propose deadlines. In addition, the proposed schedule must include deadlines for a joint list of issues and order of opening, list of witnesses and order of cross-examination; and position statements. The parties may presume position statements will be due no later than 14 days before hearing, and transcripts will be available no earlier than 10 business days after hearing. Any requests for expedited transcripts should be submitted within the period provided for filing a proposed procedural schedule.

Because of the COVID-19 pandemic, any proposed schedule should presume hearing will be conducted by telephone and video conference, subject to further order.

THE COMMISSION ORDERS THAT:

1. The parties shall promptly consult with Staff to develop a proposed procedural schedule.

2. Staff shall file a proposed procedural schedule or a status report no later than April 26, 2021.

3. This order shall be effective when issued.
