ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On February 15, 2021, Spire Missouri Inc. d/b/a Spire filed an application for a certificate of convenience and necessity regarding a natural gas distribution system to provide gas service in Buchanan County, Missouri, as a further expansion of Spire’s existing certificated area. The Commission directed a response from the Staff of the Missouri Public Service Commission (Staff) no later than April 16, 2021. On April 15, 2021, Staff filed a request for an extension of time until June 16, 2021.

Staff’s request for an extension was due to the number of data requests issued and the need for additional data requests to resolve several issues. Staff asks for a two month extension, but states it will file sooner if possible.

The Commission considers the request to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff’s request for an extension of time to file its recommendation is granted. Staff shall submit its recommendation regarding Spire’s application no later than June 16, 2021.
