

under Section 214(e)(1)-(2) of the Federal Communications Act of 1934, as amended,¹ to receive funds from the Federal Universal Service Fund. Holway Telephone Company was granted its ETC designation in Case No. TO-98-49. ETCs have additional name change requirements pursuant to Commission Rule 20 CSR 4240-31.015(2). The Commission ordered Holway Telephone Company to supplement its application with the additional name change requirements, which it did on June 11, 2026.

The Commission has reviewed the filings and Commission Rules 20 CSR 4240-28.011(2) and 20 CSR 4240-31.015(2) and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change.

The Commission gives notice that it recognizes the name change of Holway Telephone Company d/b/a Fastwyre Broadband to Holway Telephone Company, LLC d/b/a Socket Fiber.

The Commission also gives notice that the related tariff adoption sheet and updated tariff title page, filed on May 20, 2026, and assigned Tracking No. JI-2026-0142, shall become effective on June 19, 2026.
