ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: June 17, 2026

Effective Date: July 1, 2026

On January 14, 2026,¹ the Commission issued its *Report and Order* in this case, which approved the *Non-Unanimous Global Stipulation and Agreement* (Global Stipulation).

On May 28, The Empire District Electric Company d/b/a Liberty filed a tariff sheet purporting to be in compliance with the *Report and Order* and Paragraph 26 of the Global Stipulation. The tariff sheet was assigned Tracking No. JE-2026-0151 and carries an effective date of July 1.

The Commission directed its Staff (Staff) to file a recommendation as to whether the tariff sheet complies with the Commission's *Report and Order* and Paragraph 26 of the Global Stipulation. The Commission also set a time for other parties to respond.

On June 9, Staff filed its recommendation that the tariff sheet is in compliance with the *Report and Order* and Paragraph 26 of the Global Stipulation. No other responses were filed.

¹ All dates refer to 2026 unless otherwise stated.

Upon reviewing the pleadings, the Commission finds Liberty’s proposed tariff sheet complies with the Commission’s *Report and Order* and Paragraph 26 of the Global Stipulation and will approve it. To enable the tariff sheet to become effective on the date proposed, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheet assigned Tracking No. JE-2026-0151, filed on May 28, 2026, is approved to become effective on July 1, 2026. The specific tariff sheet approved is as follows:
